

YOUR APPOINTMENT

Board Member Responsibilities

Your appointment will include the following responsibilities

- Helping to lead the College, setting its strategic direction and values.
- Driving the ethos of the College to deliver a positive student experience
- Ensuring effective management and financial controls are in place that secure value for money and the efficient use of resources

Meetings are typically held **five times a year** in person and usually commence at **4:30pm.** Members normally also serve on at least one **Standing Committee.** These meetings are normally scheduled at 5:00pm and are held both online and in-person.

Board members must adhere to the highest standards of behaviour, as defined by the Scottish Government's principles of public life:

Board members must act in the interest of the College as a whole, and not as a representative of any particular group, including staff or students. Time Commitment

- Attend approximately five Board meetings per academic year.
- Serve on at least one standing committee, which meets four times per year.
- Engage in Board sessions, functions, and other College events.
- Estimated time commitment: 12 hours per month (including reading papers).

Remuneration

Membership of the Board is voluntary and unpaid; however, reasonable expenses will be reimbursed.

Period of Appointment

Up to 4 years.

- Relevant experience and skills that will enable you to contribute significantly to the governance of the College.

Person Specification

- Commitment to effective governance and the Nine Principles of Public Life.
- Eligible to undertake responsibilities as a Trustee of a Scottish Charity.
- Participation in the Safeguarding Scheme under the Protection of Vulnerable Groups (Scotland) Act 2007.

Desirable Characteristics:

- Strong written and verbal communication skills.
- Analytical skills to interpret complex data.
- Familiarity with the North and East Glasgow communities.
- Interest in supporting public service development.

- 1. A statement demonstrating how your skills and experience meet the published criteria.
- 2. A CV or short career history (no more than two pages).

We accept applications in various formats, including audio, Braille, and large print. We will also consider any disability-related reasonable adjustments to help you fully participate in the selection process.
