4. Indicative Funding Allocation 2022-23

4.1 Discussion

The Finance and Resources Director provided an introduction to the paper setting out the context and timeline of the funding allocation.

The Committee considered Foundation Apprenticeships and the rationale for some regions receiving an additional 1% allocation. Members noted the stretch targets for this year which had been developed in consultation with College Vice Principals, and had been achieved after discussion with SFC. It was noted that a meeting of a regional FA steering group had been arranged for late April to continue discussions on this allocation.

The Committee discussed the Young Person Guarantee funding stream and the request to increase the target for City of Glasgow College in particular. The Executive Director confirmed that the SFC was well aware of the request from Glasgow and that he would continue to actively pursue this.

The Committee reviewed the student support funding and the proposal to allocate some of this funding in year to allow for an in-year regional reallocation and help avoid any monies being paid back to SFC for reallocation. It was noted that this funding stream does not affect college financial sustainability as it is passed directly to students.

The GCRB running costs and Programme of Action costs were queried. The Executive Director noted that GCRB running costs are still below the expected level set out by the Scottish Government nearly a decade ago. He noted that projects within the Programme of Action are collaborative projects that benefit the students of Glasgow and are often paid directly to the colleges, such as ESOL and Bridge to Business. These projects can leverage additional funding, such as Action for Children, and meet agreed regional strategic needs while ensuring that the agreed strategic activity set out by board is delivered.

Capital funding allocations were discussed and members were reminded that this funding was provided to address backlog maintenance identified with the previous National Condition Survey. The Principals spoke of the difficulties arising from a lack of funding available to upgrade digital infrastructure.

College Principals expressed concern that the funding allocation would result in deficits for the Colleges, and would result in difficult decisions having to be made.

GCRB undertook, as always, to ensure that funding allocations were provided to colleges in a timeous fashion while ensuring appropriate governance and process is met.

- **requested** that Glasgow Kelvin College and Glasgow Clyde College provide their indicative capital plans 2022-23 to the GCRB Finance and Resources Director.
