#### 1. Report Purpose

**1.1.** Consider current progress against the 2017/18 Regional Outcome Agreement (ROA).

#### 2. Recommendations

**2.1.** The Committee is invited to **note** the contents of this progress report.

#### 3. Regional Outcome Agreement 2017/18 Progress Report

#### A) Credit Data Projections

- **3.1.** Attached as Annex A to this report is projected Credit data provided by the assigned colleges. This is based on current and planned recruitment for the 2017/18 year.
- **3.2.** This report forms part of new national monitoring arrangements and the regional data set was provided to SFC. The new Regional Lead for Student Data is working to consolidate these new national data requirements into regional reporting arrangements.
- **3.3.** The report shows that the region as a whole is broadly on track to meet its overall Credit volume targets for Core, ESF and additional Childcare activity.
- **3.4.** In terms of Core activity there is a negative variance of -386 Credits but this should be offset by the estimated over-delivery in ESF Credits of +2,097, as over the year, students currently flagged as ESF will be removed and be counted within Core Credits.
- **3.5.** With respect to delivering additional Childcare activity (beyond a 2014-15 baseline), the region is on track to deliver around 400 Credits over target.
- **3.6.** The SFC will consider these projections at a national level and may offer additional Credits to the Glasgow Region as part of a redistribution process.

# B) Regional Operational Actions

**3.7.** The following sections provide members with an update on regional collaborative work taken in relation to agreed regional outcomes, as set out within the ROA Operational Action Plan.

# Outcome 1: Right Learning in the right place:

- Meetings of the regional Learning and Teaching Group have continued to consider evidence related to the alignment of the curriculum to the social and economic needs of the region. This work has included overseeing a Curriculum Hub led review process which will support regional curriculum planning and better alignment to skills needs. The outcomes of this work will be presented within the draft 2018-19 ROA.
- Further work has been taken to initiate a review of STEM strategies, building on the curriculum hub review work and supporting the colleges and region to maintain STEM assured status. The outcomes of this STEM strategy refresh will be complete by June 2018.

## Outcome 2: Widening Access:

• The regional Community, Transitions and Supported Learning Hub has been undertaking work to review the college Access and Inclusion strategies developed by the colleges in 2017-18. The intentions of this activity are to agree standardised terminology and to use this as a basis to develop a more coherent regional strategic framework for widening access.

#### **Outcome 3: High Quality and Efficient Learning:**

 Implementation of the new quality arrangements for Scotland's colleges is continuing, and all colleges have submitted Enhancement Reviews and Plans to Education Scotland for externally verified review. These review meetings are scheduled to take place over November/December and it is planned that a regional overview of the outcomes of this activity will be provided to the December 18 GCRB Board.

#### *Outcome 4: Developing the Workforce:*

- The regional Learning and Teaching Group and the Regional Lead for DYW have been working to review Senior Phase activity and develop a regional DYW plan as part of the 2018-19 ROA. The initial focus of this work has been on a review of student activity and performance data and a formal evaluative review will be produced by January for regional consideration.
- The regional Learning and Teaching Group received a presentation from Founders4Schools, a charity which seeks to increase youth employability through ensuring that young people have at least 4 encounters with employers each year while they are age 8 -16 and 140 hours of work experience placements between the age of 16 -24. The opportunities are provided through an online platform for teaching staff and complement the Marketplace initiative directed by SDS on their

My World of Work platform. The Glasgow Colleges agreed to promote both online platforms to their teaching staff.

## 4. Risk Analysis
