1. Report Purpose

1.1. Consider current progress against the 2018-19 Glasgow Regional Outcome Agreement (ROA).

2. Recommendations

2.1. The Committee is invited to **discuss** and **note** the contents of this progress report.

3. Regional Outcome Agreement 2017/18 Progress Report

A) Credit Data Projections

- **3.1.** Attached as Annex A to this report is projected Credit data provided by the assigned colleges in May 2019. This is based on current and planned recruitment for the 2018-19 year.
- **3.2.** Members should note that in April SFC granted 1,300 additional Credits to the Glasgow College Region for 2018-19 as part of a national redistribution process. In line with these national arrangements, these were provided at a reduced value of £154 per Credit.
- **3.3.** Following discussion with the Glasgow colleges, it was agreed that the additional Credits would be distributed within the region on the following pro-rata basis:

3.4. The report provided in Annex A shows that the region and individual colleges are on track to meet their revised overall Credit volume targets for Core and ESF activity. The region as a whole is projected to deliver approximately 4,670 Credits over the combined

- Core and ESF target, a significant increase on the project surplus of 740 Credits reported at the previous meeting of the Committee.
- **3.5.** Credit projects for additional Childcare suggest that the region will fall slightly short of the targets for level 7-9 qualification courses (approximately 600 Credits). However, SFC have stated that for 2018-19, activity related to lower level pipeline training can be counted towards regional childcare targets and therefore, it is not assessed that the current projections constitute a significant risk to the region.
- **3.6.** Recruitment of Senior Phase age pupils studying vocational qualifications (at SCQF 5+) is significantly above target with over 1,000 pupils enrolled compared to the targeted 778, evidencing the regional commitment to delivering the aims of Developing the Young Workforce.
- 3.7. There is a projected shortfall in SIMD 10 targets with this predicted to be around 2,600 Credits below the target of 117,716 Credits (representing a reduction in the projected shortfall from 5,000 Credits as reported at the previous meeting of the Committee). Whilst the colleges will continue to undertake actions which promote access to learners from deprived postcodes, given the point of time in the current academic year it would seem unlikely that this shortfall can be further significantly reduced.
- **3.8.** 'One plus' Credits have increased slightly compared to the previous report, with the regional level now 0.4 percentage points above the 2.5% threshold set by the SFC. However, this should be more than offset by forecast additional activity delivered beyond the core Credit target and therefore the region should still be below overall permitted levels. However, given the increase, this will continue to be closely monitored by GCRB and the colleges.
- **3.9.** Progress in respect of regional targets for economic sector activity show some relatively minor variation against planned levels with the most significant change continued growth in transition and supported learning activity to support regional widening access ambitions, alongside an increase in Health and Care delivery related to additional childcare activity.
- **3.10.** The GCRB Executive Director and the regional Learning and Teaching Group will continue to monitor and support progress towards ROA target achievement.

B) Regional Actions

3.11. The following sections provide members with an update on regional collaborative work and developments relating to agreed regional outcomes.

Outcome 1: Right Learning in the right place:

As part of ongoing activity to improve skills alignment, GCRB continues to engage
with a newly formed Financial Services Employers Hub organised jointly by Skills
Development Scotland (SDS). As reported previously, SDS engaged across a range of
Financial Services employers (including Barclays, JP Morgan, HSBC, Morgan Stanley,
BNP Paribas, and Tesco Bank) to develop a skills training demand statement. In
response to regional discussions, City of Glasgow College has now developed a parttime, level 7/8 Financial Services course college and university graduates. GCRB has
allocated additional Credits to the College to fund a pilot of this course, which is

being delivered over May and June 2019. The course includes significant employer input and successful completers will be offered an opportunity to be interviewed for positions within the Financial Services industry.

Outcome 2: Widening Access:

- The Regional Leads for Student Experience and Student Data and the GCRB Executive
 Director are participating in meetings progressing implementation of the Scottish
 Government's Learner Journey review. The focus of the joint work is on improving
 access to the full regional curriculum through the Skills Development Scotland My
 World of Work website, alongside improving data collection on student demand.
- Following the publication of a Scottish Funding Council report on articulation, the
 regional Learning and Teaching Group received a presentation from Dr Scott
 Montgomery, Senior Policy/Analysis Officer at the Scottish Funding Council on the
 articulation portal which provides access to collated data. Going forwards, this
 information source will support curriculum planning and review activity at both
 regional and institutional levels.

Outcome 3: High Quality and Efficient Learning:

• Glasgow Kelvin College is the sole mainland college provider of full-time Gaelic courses. Building on the success if this provision, following liaison with the SFC and GCRB, the Glasgow College Region was awarded a grant of £13,900 to support the delivery of a Gaelic Immersion Residential Course. Delivered by Lews Castle College Gaelic department, the course offers Glasgow college Gaelic students an intensive one week course using the Ulpan language teaching method. The course also includes a programme of excursions to various places of interest on Stornoway. This cultural element of the residential course gives the students an opportunity to hear Gaelic spoken by local people in their own dialect in various districts of the island. Representatives

Outcome 4: Developing the Workforce:

Representatives from across the Glasgow College Region participated in a Foundation Apprenticeship review meeting held at the offices of Skills Development Scotland. The meeting provided an opportunity for college, local authority and SDS representatives to consider progress to date, and to discuss potential improvements and developments to the programme. The recent introduction of additional Foundation Apprenticeship providers was included in these discussions, and the meeting provided an opportunity to consider how future commissioning arrangements could ensure the continued coherence and accessibility of the regional Foundation Apprenticeship offer.

Building on the success of the regional FA programme, GCRB and the colleges submitted a funding bid to Skills Development Scotland to support the development of the Foundation Apprenticeship programme to levels 4/5 in 2019-20. This would offer Senior Phase pupils a more modern and work relevant alternative to the Skills for Work qualifications in construction, automotive and hospitality. The new courses will constitute 4 units of study and focus on project-based activity delivered in partnership with an employer. It is hoped that SDS will provide funding for a project

coordinator to support the identification and integration of partner employers for each course.

4. Risk Analysis

- **4.1.** This paper addresses GCRB Risk 008: Failure to achieve the targets set out in the Regional Outcome Agreement lessens our ability to meet regional needs.
- **4.2.** As referred to in the body of the report, an area of risk relates to the level of 'one plus' activity and the GCRB Executive Director will continue to work with college colleagues to monitor college levels of activity considered additional.

7. Financial Implications
