**3.2.** The following variations to the running costs are highlighted:

#### <u>Income</u>

- **Regional Grant** this is the amount set aside from the indicative grant allocation to the Glasgow college region.
- **Brought forward funding** reflects the utilisisation of a balance brought forward from earlier years.

## **Expenditure**

• Staffing – the modest increase reflects the forecast additional staffing costs arising from the annual salary settlement (forecast significantly below inflation).

**4.2.** The following variations to the regional Programme of Action are highlighted:

#### Income

• **Regional Grant** – this is the amount set aside from the indicative grant allocation to the Glasgow college region.

- **SFC strategic funding** will be included within the forecast if, and when, it is confirmed by SFC.
- **Brought forward funding** reflects the latest forecast out-turn for 2022-23 and utilisisation of a balance brought forward from earlier years.

### **Expenditure**

- Action 4 Children the extension of this project (from 2021-22) was approved by this committee and will continue in 2023-24.
- Young Enterprise Scotland this is the extra regional provision, in addition
  to the service supported directly by the Scottish Government. A small
  increase in budget is proposed.
- English for Speakers of Other Languages (ESOL) the partnership project will continue to be managed by Glasgow Clyde College.
- **Curriculum/Strategic Planning & Regional Review** there is no work currently planned for 2023-24 which requires GCRB funding.
- Mental Health a small amont of regional activity is envisaged.
- **Counsellors** were funded via a separate Scottish Government/SFC grant in 2022-23. It is proposed that support continues in 2023-24. Regional support will help to maintain this service in the most effective manner possible.
- Climate Change/Sustainability the fixed term project is currently planned until the end of 31 July 2023. It is proposed that the project is extended to 2023-24, albeit at a lower budget.

#### 5. Performance and Resources Committee

**5.1.** The indicative GCRB budget 2023-24 was considered by the Performance and Resources Committee on 15 March 2023. The indicative budget was discussed by the committee and is now presented to the Board for approval.

## 6. Risk and Compliance Analysis

**6.1.** There are no specific risks associated with this report. The delivery of the regional programme of action addresses key elements of the strategic plan and mitigates some of the regional risks.
