1. Executive Summary

- **1.1** The regional environment and sustainability strategy has been developed from the draft strategy presented to the board in November 2021, and with the input and agreement of the regional environment and sustainability group.
- **1.2** Our broadest aims remain similar and some of our planned activities have been amended to optimise opportunities and focus on ambitious though achievable objectives.
- **1.3** This strategy aligns with the Scottish Government's Fairer and Greener Scotland priorities and with the Glasgow region's priorities.
- **1.4** It is also flexible enough to support our colleges' activities on the environment and sustainability and is not meant, at this stage, to be exhaustive.
- 1.5 The regional strategy is based on the FE climate Change Roadmap and seeks to help our colleges reach its milestones collaboratively and individually. The Roadmap also supports the United Nations Goals for Sustainable Development.
- **1.6** This strategy extends beyond the Roadmap to develop further work on changing people's behaviours to be more sustainable, and on the circular economy.

2. Recommendations

2.1 The board is recommended to **approve** the environment and sustainability strategy.

3. Risk and Compliance Analysis

3.1. This strategy mitigates the risk that GCRB and the Glasgow college system is unable to take the coordinated action to deliver and progress regional environment and sustainability strategy in line with Glasgow's commitment to the Scottish Colleges' Statement of Commitment on the Climate Emergency and associated climate action road map.

4. Financial and Resource Analysis

4.1 The implementation of this work requires the commitment of staff resources and some additional expenditure. This is contained within the GCRB operational budgets for 2022/23.

Introduction

Colleges have always sought to equip learners with the knowledge and skills to succeed in a changing world. Now, as we face the Climate Emergency, a post pandemic society, and a global economic crisis, the need for that knowledge and those skills has never been more acute.

College learners have the potential to make a powerful impact on the Glasgow region's Green Recovery and Just Transition. They are local learners who are likely to become local workers in sectors that must respond quickly to achieve Scotland's Net Zero Target.

College communities reflect Glasgow's social and economic diversity and our learners will have impact and influence as citizens and consumers.

Glasgow's colleges will play a vital part in reaching Net Zero, in building a sustainable future, in strengthening communities and in developing the regional economy.

This strategy will help our college network to take a leadership role, working in together and with partners to build a better future.

Aims

We will deliver more positive change than could happen without a regional approach; harnessing regional scale, efficiency and vision while supporting each college's specific strategy and activities by:

- Helping to reduce the Glasgow College Region's environmental footprint
- Aligning with the regional strategic curriculum review, contributing to Glasgow's Green
 Recovery, and offering learning that will help meet the Fairer, Greener Scotland priorities.
- Offering a college experience that motivates and enables its learners, staff and partners to change their policies, ways of working or behavior to reduce climate change, consumption and waste and support global sustainable development.
- Developing partnerships that help shape, deliver and fund actions.
- Contributing to regional and national environmental discourse, research and momentum.
- Optimising collaboration in the Glasgow College Region.

Strategy

This strategy is structured to align with the Further Education Climate Action Roadmap because it offers a complete approach to meeting our colleges' commitments to the Scottish Colleges Statement of Commitment on the Climate Emergency. Our colleges have signed that commitment and are using the Roadmap whose themes are: Leadership and Governance, Learning and Teaching, Estates and Operations, Partnerships and Data Sharing.

While the Roadmap offers sound structure, prioritisation and measurement of progress on the environment and sustainability, it is far from exhaustive. We are ready to work with colleges on activities that support, but are not included in the roadmap.

To help effect changes in our people's understanding and behaviours around the environment and sustainability, we have added a sixth workstream to deliver communications that will inform, motivate and enable change and support our colleges' activities

Our wider sustainability activities align with the United Nations Goals for Sustainable Development. This aligns with the Scottish Government's commitment.

We have added activities that promote the Circular Economy. Again, this aligns with Scottish Government and Glasgow City Council strategies. It also supports teaching and learning for a sustainable future.

1. Leadership and Governance

Our aim

Leadership and Governance for sustainable development aims to support Glasgow's colleges, collectively and individually, as they integrate a wide range of environmental and sustainability priorities into their values, culture, learning, teaching, research and other business activities.



Glasgow Colleges' Regional Board offers strategic direction and support.

2. Learning and Teaching

Our aims

This strategy takes a holistic approach to learning for a sustainable future. It is aims to inform, motivate and enable our learners to make sustainable choices as citizens. It is also designed to support the Just Transition and Green Skills agenda and promote the UN's Sustainable Development Goals. We recognise the importance of the whole college experience: the formal and informal curricula, staff development, life on campus and extra- curricular activity.


Carbon literacy for all: A regionally-produced online learning module will offer core carbon literacy training to all students and staff. Colleges will be able to brand the module and add their own content.

Staff development: We will offer on-demand support to staff seeking training on sustainability themes or vocationally- relevant topics.

Curricular support: We will offer on-demand support to learners in any faculties and courses with an identified need or interest in sustainability. We will also include environmental and sustainability considerations in the regional curricular review.

Climate Fresk: We will deliver at least one Fresk/ month to students and staff with an interest in climate change.

Extra-curricular: We will work with the colleges and students' associations encourage engagement though campaigns, events and initiatives on sustainability themes.

Collaboratively, we will have delivered 3 initiatives on extra-curricular sustainability themes

3. Estates and operations

Our Aims

Our colleges are working individually to meet the agreed Net Zero target and, in doing so, are working towards the estates and operations milestones. Our regional aims are to support their activities with communications that encourage sustainable behaviours and to help identify funding for changes in estates and operations.

Our deliverables

Milestone

Ensure recycling/signage is available in every building Emerging college milestone

Action

Offer campaign signage and communications assets to all colleges. Messaging will include recycling and encourage further sustainable behaviour such as reducing use of disposables, energy and food waste.

Our objective by July 2023

To have supported at least two on-campus behaviour change initiatives and measured and shared their results

4. Partnerships

Our Aims

The Glasgow colleges have met most of the Roadmap's milestones in partnership working. We will continue to work with Skills Development Scotland and regional partners on the Just Transition and Green Skills agenda. We will also work closely with the Students' Associations, supporting their individual activities and channelling regional work through them

Our regional aim is now also to develop ambitious partnership activities that broaden our influence and impact on the region's sustainability.

Our deliverables

Milestones

To support the Scottish Government's and Glasgow City Council's commitment to the circular economy.

To add to the further education sector's understanding of its students' and staffs views on the environment and sustainability.

Actions

We will deliver an event, in partnership with Bridge to Business, to promote the values and possibilities of the circular economy to young people.

We will work with the College Development Network and the EAUC to deliver, share results and further develop our research.

Our objectives by July 2023

At least 100 young people and 50 staff will have attended our circular economy event

We will have delivered Scotland's first survey of college students' and staffs' attitudes to the climate emergency

5. Communications, engagement and behaviour change

Our Aims

While not a theme in the Climate Action Roadmap, this work stream aims to:

- deliver communications that engage learners, staff, our partners and our communities in the fight against the climate emergency and for the Sustainable Development Goals.
- support the delivery of the other five workstreams.
- support each college's environmental and sustainability strategies and activities.
- develop a regional college culture that motivates and enables people to change their beliefs and behaviours that help to address climate change.

Our deliverables

Milestones

To support the Estates and Operations milestones by encouraging sustainable behaviour on campus

To build engagement with the Sustainable Development Goals

To nudge changes in behaviours

Actions

We will create and offer consistent, branded communications collateral, encouraging behaviour changes that increase recycling, reduce energy use, reduce the use of disposables, reduce food waste and encourage responsible consumption.

We will offer communications collateral, in advance of the Global Goals Teach-in, that explains and encourage alignment with each of the goals.

We will issue a newsletter each term and a Christmas edition. From these, we will spin out content that colleges can share via social media and their own communications channels.

Our Objectives by July 2023

We will have delivered communications that promote 17 Sustainable Development Goals and 1,000 of our learners will received or engaged with our content and or Teach-Ins.

We will have issued 3 newsletters and at least 50 pieces of shareable content on sustainability themes. At least 1,000 people will have engaged with our messaging.

6. Data Sharing

Our Aim

Our colleges fulfil their carbon reporting obligations and meet the Roadmap's milestones in data sharing. Our regional aims, in addition to supporting that work, are to add data and research findings to the sector's knowledge.

Actions

We will offer training in measuring emissions and carbon footprints to colleges' key staff

We will share data from our survey of staff and students' views on sustainability with the EAUC and the College Development Network

We will share our evaluations of communications, SDG and Climate Fresk activities, and initiatives on reducing disposables, etc with the sector and the organisers of initiatives.

We will have helped to upskill key college staff on carbon reporting

We will have shared at least three reports with the further education and environmental sectors

Scottish Colleges' Statement of Commitment on the Climate Emergency February 2021: 10 key actions

- 1 Support Scotland's efforts to achieve net-zero climate emissions by 2045 or earlier if possible, with Scotland's colleges aiming to achieve net-zero by 2040 or earlier.
- 2 Embed environmental sustainability in our institutional strategies and set measurable targets.
- 3 Address the UN's Sustainable Development Goals in our strategies.
- 4 Share best practice within and beyond the college/university sector.
- 5 Deploy our expertise and experience to combat climate change.
- 6 Contribute to public debate on climate change and use the power of our example to encourage others.
- 7 Work with Scottish industry, employers, public sector bodies and others to improve working practices and find practical solutions to climate change and to make our planet safe for future generations.
- 8 Encourage, where appropriate, colleges to adopt the UK HE/FE Climate Commission's 'Climate Action Roadmap for FE Colleges'.
- 9 Each college will publish action plans to address on-campus and supply chain emissions, setting out what steps they will take over a five-year horizon and beyond where possible, and what they aim to achieve to address the climate emergency.
- 10 Educate staff, students, employers and communities on the impact their daily lives and working practices have on the environment/climate. While working with our partners, local employers and communities to ensure everyone is aware of their personal responsibility to our planet.
