1. Report Purpose

- 1.1. Consideration of the overall process and timetable for managing GCRB and assigned college appointments during 2015-16.

2. Recommendations

- 2.1. The Committee is invited to:

- **Comment** on the proposed timetable for managing GCRB and assigned college appointments during 2015-16.
- **Agree** to recommend to the Board that the current Vice-Chair of City of Glasgow College is appointed Interim Chair of the College, until the earlier of the date when the new permanent Chair takes up post or 31 July 2016.

3. Background

Committee terms of reference

- 3.1. The Committee's terms of reference give the Committee the role of overseeing the appointments process for both GCRB members and assigned college members, and for making relevant recommendations to the Board of GCRB.

Current and future vacancies

- 3.2. Annex A lists all current and future vacancies. Aside from the imminent appointments referred to in one of the other papers being considered at today's meeting, in summary:
- There are currently 6 vacancies at Glasgow Clyde College and 1 vacancy at Glasgow Kelvin College.
 - Five members of GCRB are eligible for appointment for a second term as at 30 April 2016 (this is discussed in more detail in a separate paper for today's meeting)
 - 23 members' terms of office in the assigned colleges come to an end on 31 July 2016

(including the Chair of Glasgow Kelvin College).

- 3.3.** In addition, we have recently been advised that the current Chair of City of Glasgow College will resign on 31 October 2015.

4. Issues to be managed

- 4.1.** These requirements throw up several important issues which will need to be managed carefully. The following comments take account of initial discussions that have been held between GCRB and relevant officers in the assigned colleges.
- 4.2.** Careful thought has to be given as to whether Glasgow Clyde's vacancies are addressed now or are encompassed within the main appointments process. Glasgow Clyde officers are seeking to discuss with the College Chair on the relative advantages and disadvantages.
- 4.3.** Similarly, we will discuss with City of Glasgow College the most appropriate timing for the recruitment of its replacement Chair.
- 4.4.** This is a very large number of appointments to be achieved in a relatively short period of time. Although there could be some advantage to running multiple smaller appointment processes, it is felt we should aim for a single process that concludes as early as reasonably possible so that there is the opportunity to run a second stage if insufficient members are identified in the first run.
- 4.5.** There will have to be very careful co-ordination of the appointments processes across the three colleges, especially during the advertisement stage.
- 4.6.** Given the importance of seeking members from each college's 'communities' (both geographical and otherwise), the primary branding should be that of each college. However, given the risk of insufficient applicants with the right knowledge, skills and experience, we will aim to put arrangements in place so that applications can be 'shared' across the three colleges.

5. Timetable

- 5.1.** Annex B sets out the indicative overall timetable. Although it concludes well before the 31 July deadline, doing so has the twin advantages of:
- Leaving sufficient time for proper induction to take place before the new members take up their positions formally.
 - Allowing for the possibility of a second round if the first round fails to appoint sufficient members

6. Interim Chair of City of Glasgow College

- 6.1.** Since the current Chair of City of Glasgow College will resign on 31 October 2015, there will be a gap before his permanent replacement is identified. This also means there will be a temporary vacancy on the Board of GCRB. It is not felt appropriate for there to be such a gap without some form of interim arrangement.

6.2. City of Glasgow College has an identified Vice-Chair. It is proposed to seek confirmation from the College's Board of Management (and the Vice-Chair himself) that it is content for him to be appointed as Interim Chair and for GCRB to seek authority for that from Scottish Ministers (as it is required to do). As Interim Chair he would also be a full member of the Board of GCRB.

7. Risk Analysis

7.1. This paper addresses the risk that the membership of the GCRB and the assigned colleges does not meet their requirements in terms of number and knowledge / skills / experience.

8. Legal Implications

8.1. The legal and regulatory aspects of this matter are addressed within the body of the paper.

9. Financial Implications

9.1. There are no new financial implications arising from this paper.

10. Regional Outcome Agreement Implications

10.1. There are no specific implications for the Regional Outcome Agreement associated with this paper.
