1. Executive Summary

1.1. The report below provides a review of progress of the college capital projects for the financial year (FY) ending 31 March 2023. The report highlights progress made by the colleges from 1 April 2022.

2. Recommendations

2.1. The Committee is invited to **note** the progress made by the colleges in respect of the capital projects in the financial year ending 31 March 2023.

3. Background

3.1. The distribution of capital funds for 2022-23 was allocated to the colleges as follows:

4. Glasgow Clyde College Update

- **4.1.** Glasgow Clyde College is implementing its capital plan, and progressing a range of high priority projects, following the allocation of these funds by GCRB.
- **4.2.** Glasgow Clyde College have been, and continue to work with, Doig & Smith, the appointed project manager team progressing the projects in the capital plan for 2022-23. Doig and Smith were appointed for a two-year period for these services following a tender process. The capital projects have been progressed in partnership with Doig and Smith with fortnightly discussions taking place with college colleagues. There have been a range of additional discussions particularly in relation to the render/windows project at the Anniesland campus.
- **4.3.** The costs have been revised for several projects, as a result of the progress of design and scope. There are three projects where there have been significant changes since the original plans were developed.
- **4.4.** The first of these is the evolving situation in respect of the original Anniesland render repairs project². The other two projects with significant changes are; the Cardonald campus lifts project and the heating and cooling project at the Anniesland campus. For both of these projects there have been significant cost increases compared to the original plan.
- 4.5. The Cardonald campus lifts project is a project to address significant issues with the five lifts at the ten-storey tower building. These lifts have not been which properly and, whilst safe, there are problems in the effective functioning of their combined controls. The lifts are also prone to plus break down frequently sometimes with student and/or staff entrapments. The original target budget cost was an estimate and the scope has changed significantly to fully address the defects. This is a long programme of 46 weeks which will continue into the next financial year. The commitment of £750k is for the full five lifts upgrade project. The college expects to meet the cost from the capital funding allocation for 2022-23 and 2023-24³.

- **4.6.** The heating and cooling and chillers project at Anniesland was originally two separate projects which have been combined. The scope of this project was enhanced (at tender stage) to provide the most beneficial outcome including elements of upgrading. Some of these enhancements will provide more efficient equipment with lower future utility consumption and a better overall investment.
- **4.7.** Overall the total commitments are £2.92m which is £0.83m higher than the total allocation (for high priority maintenance in 2022-23) of £2.09m.
- **4.8.** The challenge is that large capital projects span financial years but funding is only allocated by the Scottish Funding Council annually for the year commencing 1 April. The funding is also announced after the start of this period, which further reduces the time available for project planning, tendering and delivery.
- **4.9.** The approach proposed by college colleagues has been discussed with the GCRB Finance and Resources Director and provides a pragmatic approach to the capital projects. Clearly there is a risk that the anticipated capital funding for 2023-24 is not forthcoming. If the funding provided for 2023-24 is insufficient then the college would need to revise its future programme of works.

5. Glasgow Kelvin College Update

- **5.1.** Glasgow Kelvin College is implementing its capital plan, and progressing a range of high priority projects, following the allocation of these funds by GCRB.
- **5.2.** The capital plan was slightly amended as the college is awaiting a report in relation to the Springburn external cladding panels. The original budget allocated to this project was not possible to complete prior to 31 March 2023 and other projects were undertaken instead.
- **5.3.** Furthermore, some of the carpets will also be fitted early April 2023 to avoid disrupting learning and teaching during March 2023.
- **5.4.** The changes to the project, outlined above, were discussed with the GCRB Finance and Resources Director.

6. City of Glasgow College Update

6.1. City of Glasgow College received £1,336,088 in 2022-23 towards the cost of lifecycle maintenance. This is being used to meet the cost of the NPD unitary charge and to meet maintenance costs not included in the NPD contract.

7. Risk and Compliance Analysis

- **7.1.** One of the key risks facing the Glasgow Region is that "Financial sustainability is jeopardised by a reduction in funding and/or an increase in costs." (Risk 008). The provision of additional capital funding helps to mitigate this risk.
- **7.2.** The capital plans for Glasgow Clyde College, and Glasgow Kelvin College, represent a significant investment in 2022-23. The funds provided are essential in reducing the financial risk and providing the appropriate facilities for learning.
